Re: Date and place of the IUBMB General Assembly 2015

Dear Colleagues,

According to Statute 5.2, the date and place of an Ordinary General Assembly shall be decided by the Executive Committee, and notice of it shall be sent in writing by the General Secretary at least 9 months before the proposed date to the Contact Person of each Adhering Body and Associate Adhering Body, to the Chairs of all Committees set up by the Union, to the Chief Representative of the Union on Joint Committees and other joint bodies, and to the Executive Committee. I am therefore informing you that the Executive Committee, at its last meeting in Taipei on October 22, 2014, confirmed that the next Ordinary General Assembly will take place on *Friday, August 28, 2015 at 14:00 in Foz do Iguaçu, Brazil* during the 23rd IUBMB Congress & 44th Annual SBBq Meeting (August 24-29, 2015): http://www.sbbq.org.br/iubmb2015/. The General Assembly will be held in Iguaçu Rooms II/III of the Rafain Convention Center and Hotel, the venue for the Congress.

According to Statute 4.1, each Adhering Body shall have the right to appoint a Delegate or Delegates, and each Associate Adhering Body the right to appoint one Associate Delegate, to the General Assembly. The number of Delegates which each Adhering Body has the right to appoint is determined according to Statute 4.2 and is indicated in the **attached table** at the end of this message. According to Statute 4.3, each of the Delegates present at a General Assembly shall have one vote only. According to Statute 4.4, the Associate Delegates shall participate, but shall not have a vote at the General Assembly.
